NEW SHOOTING RANGE

The Ottawa County Sheriff's Office recently received a generous donation of land, materials, and labor to build a private firing range from the Kwest Group and Ryan Odendahl of Port Clinton. The Kwest Group is located just outside of Port Clinton and provides civil construction and environmental services throughout the United States and Caribbean. The new range is located outside of the city of Port Clinton.

The range has many great features and will enhance the training of Ottawa County Sheriff's Deputies. Weapons training at the range includes pistol, patrol rifle, SWAT rifle, and sniper rifle training. The range features a range line with a capacity of 15 shooters and the ability to shoot in 180 degrees from 50 yards out from targets. The range is currently outfitted with 30 target stands to hold Ohio Peace Officer Training Academy targets and 15 steel targets. Future plans include additional steel targets and more moveable walls and barricades.


All Ottawa County Sheriff's Deputies will receive additional training at the new range once the Office's new Glock 45 pistols arrive. The new Glock 45 pistols feature an attached flashlight and Holosun green dot sighting system to allow our deputies to better acquire targets and improve accuracy. Ottawa County Sheriff's Office Deputies, SWAT Team, and members of the Ohio Tactical Officers Association have held several training sessions at the new state of the art facility.

OTTAWA COUNTY SHERIFF'S OFFICE DIVE TEAM

The Ottawa County Sheriff's Office Dive Team located two vehicles at the bottom of a quarry at Veterans Memorial Park in Genoa after receiving a tip. Members of the Ottawa County Sheriff's Office located at least two tires that appeared to be attached to vehicles during a training exercise. It was later determined that the vehicles were not related to any crime. The partial vehicles were removed from the quarry with the help of the Ottawa County Sheriff's Dive Team, Members of the Ottawa County Sheriff's Detective Bureau, Toledo Fire Department, Ohio Bureau of Criminal Investigation and Identification (BCI) Forensic Dive Team, two Special Agents with their Crime Scene Unit, and Pat and Son's Towing. These specialized Deputies also make warrant arrests and deal directly with all courts within Ottawa County. They also work with other jurisdictions in and out of Ohio to serve paperwork and make arrests. They receive the same training as the road deputies and are also Ohio Peace Officer Training Academy (OPOTA) Certified Law Enforcement Officers.




Left- Deputy Rhonda Reiter. Right - Deputy Kendra Dosh

OTTAWA COUNTY SHERIFF'S OFFICE MARINE PATROL

Did you know that your Ottawa County Sheriff's Office has a Marine Patrol unit? The OCSO's Marine Patrol Unit operates a Boston Whaler to patrol the more than 330 square miles of waterways in Ottawa County. Marine Patrol Deputies have specialized training to safely operate the boat and assist with waterway-related emergencies. Marine Patrol Deputies enforce the laws of Ohio, assist boaters, and conduct safety inspections upon request or in the event of a violation.


The Ohio Department of Natural Resources and the United States Customs and Border Protection provides funding for the OCSO Marine Patrol Unit. OCSO Marine Patrol also partners with the United States Coast Guard Marblehead Station. Gem Beach Marina provides dockage for the patrol boat.
